THERE is probably nothing of so great importance to the public which is given so little thought as the question of water supply. You don't need to be a chemist or a doctor to understand it, all you need is to apply a little common sense. For an experiment, fill a glass with water from the public supply of any large city and hold it to the light. Now what do you see in it? Dirt, iron rust from the pipes it has passed through and sometimes, a greenish scum from the vegetable matter in it. The things which you don't see, but which are there just the same, are disease germs, ammonia, sewage, drainage from field and shop, mineral matter and the essence of all sorts of pollution. Such water is not fit to drink, yet you drink it just the same, six or more times a day. Bring common sense into play and answer this question: Am I willing to drink dirt when I would not eat it?

IMPURE WATER causes typhoid fever, dyspepsia, dysentery, cholera, scarlet fever, malarial fever, ague, rheumatism, gout and goitre.

BOILED WATER is not pure, the boiling may kill the germs of disease but it does not remove them.

FILTERS are nearly useless for they remove nothing but the sedimentary matter. The best and most expensive filters made will not remove the germs of disease.

BEWARE OF CHEAP SPRING WATERS for many of them are inferior to the public supply. Do not drink spring water till you have seen an official analysis of it. Visit the spring if possible, examine the surroundings carefully and avoid a spring, which is in a low place, near buildings, or upon cultivated land or in any place where it can receive drainage for under those conditions the water may be good today and tomorrow filled with impurities.

The spring basin is carefully lined and covered with stone and tightly cemented, excluding all contamination. The bottling house is connected with the spring by a pipe which discharges the water directly into the bottles as it is wanted so practically PURITAN SPRING WATER does not come in contact with the air until it is placed on the table of the consumer.

The analysis shows that you have a most excellent water for drinking. It is clear, soft and odorless with no sediment or color. The sample shows not the slightest trace of sewerage or surface drainage and there is practically no organic material in solution. In fact there is less organic material in solution in the water than in any sample that we have analyzed at the laboratory up to this time. The amount of Chlorine in the water is well within the normal, and nitrates and nitrites are entirely absent. I regard the water as a most excellent one for all domestic uses.
